**Young Palestinian Leaders Visit New Jersey on the Heels of Annapolis Conference;  
Delegates to Engage in Dialogue with Local Political Leaders, Study American Political System**

WASHINGTON – From November 8-11, 2007, a delegation of six young, prominent political leaders from the Palestinian Territories will visit Princeton and Trenton, New Jersey, as part of a ten day political exchange program organized by the American Council of Young Political Leaders (ACYPL) and funded by the U.S. Department of State. The delegates kicked off their program with meetings and briefings in Washington, D.C. only days after the conclusion of the Annapolis conference on Middle East peace and will arrive in New Jersey after a visit to Oklahoma. While in New Jersey, they will be hosted by Mercer County Freeholder Tony Mack, a 2003 ACYPL delegate to Morocco.

ACYPL began exchanging delegations with the Palestinian Territories following the 1997 Phase I of the Likud-Fatah Dialogue – a political skills training program that brought together rising leaders from the Israeli Likud Party and Palestinian Fatah Party's youth organizations who were interested in engaging their colleagues across the Israeli-Palestinian conflict.

**Who:** Political leaders between the ages of twenty five and forty who represent the next generation of Palestinian leaders. Delegation members include:

**What:** Program highlights will include:

- Meetings and discussions with Ewing Township Mayor Jack Ball, New Jersey State Senator Joseph M. Kyriillos, an ACYPL Trustee and 1994 ACYPL delegate to China and Hong Kong, New Jersey State Senator Diane B. Allen and other members of the New Jersey state legislature;
- "A Conversation on the Future of Palestine," a public forum to be held on Sunday, December 9, 2007 at Princeton University's Woodrow Wilson Center and moderated by Freeholder Tony Mack;
- A press availability in Room 103 of the New Jersey State Capitol from 12-12:30pm on December 10, 2007; and
- Tours of the New Jersey State House, the Mercer County Prosecutor's Office, the municipal government offices of Ewing Township and the Mercer County Agricultural Extension Center.

**When:** December 8-11, 2007

**Why:** The purpose of this exchange program is to:

- Expose the delegates to the American political system at the national, state and local levels;
- Give them a new perspective on American culture; and
- Allow them to engage in dialogue on international issues and forge professional relationships with their American counterparts.
